Inclusive and Accountable Governance and Women's Access to Justice

Public trust in the justice system is improving. In 2023, public trust in the justice system stood at 69% according to data collected from the SEMA pilot program located at 50 frontline JLOS service points (JLOS annual report, 2022/23). This presents a 7-percentage point increase from the 62% reported in 2022. There is significant improvement in the capacity of justice institutions to deliver gender responsive justice services. This year, a costed strategy for the management of gender-based violence cases in the Judiciary using a survivor centred approach. This is expected to improve the management of GBV cases through the Uganda Police Force (UPF), Office of the Director of Public Prosecutions (ODPP), and the Judiciary. The composition of women in governance positions has not changed much. Women still constitute 33.8% of seats in Uganda's national parliament, 46.5% of ministerial positions, and 46% of local government councilors.
