At regional level, partnership with ECCAS resulted to the drafting of the first biding regional EVAW Convention if adopted in 2024 it will have a real impact on the lies and right of estimated hundred million women and girls in the region of Central Africa that are currently subject to SGBV. At country level CAR developp the law on sexual harassment in school to protect girls rights and access to education on post-conflict environnment.
