India: Law For Women Legislators

💡 India

On 21 September, Indian legislators passed the first legislation considered in the country's new Parliament building: the Women's Reservation Bill, 2023. The bill, which passed both houses of Parliament almost unanimously—with just two votes against—will ensure that women occupy at least 33 percent of the seats in state legislative assemblies and the Lok Sabha, the lower house of Parliament. Arab States: Gender Equality In The Law

Beirut, 10 December 2023 – Within the framework of the Annual Periodic Review of legislative updates for Arab States participating in the "Justice and Equality between Women and Men in the Law" initiative, 15 of the 17 participating countries presented national legislation that was introduced or amended during the period of 2022-2023. The legislation was reviewed by legal experts from the United Nations Economic and Social Commission for Western Asia (ESCWA), the regional offices of the United Nations Population Fund (UNFPA), the United Nations Entity for Gender Equality and the Empowerment of Women (UN Women), and the United Nations Development Programme (UNDP). The revisions were added to the Initiative's website, providing the most up-to-date legislation in the Arab region. Read more>

North Macedonia now has expanded protection for various forms of violence against women with the adoption of new amendments of the Criminal Code which align the country's laws with the Convention on Preventing and Combating Violence against Women and Domestic Violence, also known as the Istanbul Convention. National Adaptation Plan (NAP) processes are a way for governments to direct resources to such efforts, focusing particularly on vulnerable sectors such as agriculture, water resources and infrastructure, and enhancing coordination and collaboration among different stakeholders involved in adaptation planning and implementation.
