**By 2024, vulnerable people have improved access to social welfare services, including in humanitarian context.**

Vulnerable communities have access to information on basic social services, especially those facing multiple forms of intersecting discrimination. 1,000 women and vulnerable children from Bamako, Sikasso, Ségou, Bougouni and Koutiala reinforced their knowledge of GBV and menstrual hygiene management. They were provided with menstrual management kits and knowledge of the various means of contraception and prevention against sexually transmitted infections.
