The Network builds on African women’s leadership to increase women’s participation in decision-making through peer learning and mentoring, enhanced solidarity, advocacy, and capacity-building among other strategies [1] DRC, Cote d’Ivoire, Central African Republic, Sierra Leone, Congo Brazzaville, Seychelles, Nigeria, Ethiopia, Morocco, Liberia, Cameroon, Benin, Tanzania, Zimbabwe, Uganda, Mali, Mozambique, Malawi, Niger, Kenya, Namibia, Tunisia, Gabon, Lesotho, Sao Tome, South Africa, Zambia, Angola, Senegal, Guinea, Ghana, Rwanda, and Gambia.
