High quality of programmes through knowledge, innovation, result-based management and evaluation

Due to the escalation of war and subsequent humanitarian and security crisis, no external audits were conducted, and only limited participation in evaluations/assessments was possible. The Country Office participated in the regional evaluation on capacity development. The evaluation continues into the first quarter of 2023, and no lessons learned can be extracted yet. The project “Decentralization and Law Enforcement Reforms: Transformative Approaches to Gender Equality and Women’s Empowerment in Ukraine” (2018–2022) underwent a light final project assessment, which was concluded in December 2022. The report highlights important lessons learned and recommendations for future programming, including how UN Women can continue working with the National Police of Ukraine on gender-responsive policing and with the media for social norms change. High quality programmes and results-based management was ensured through ongoing monitoring activities and developing progress reports on all project’s progress and results. Specific humanitarian indicators were also developed, as complementary to the SN indicators, to ensure all results were captured in the evolving humanitarian crisis.
